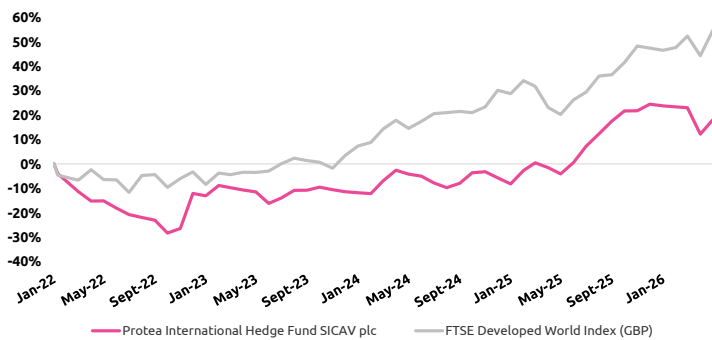
## Fund Profile

The Protea International Hedge Fund SICAV plc ("Fund") is organised under the laws of Malta as a multi class public limited liability company with variable share capital (SICAV) pursuant to the Companies Act (Chapter 386 of the Laws of Malta). The Fund is licensed by the Malta Financial Services Authority ("MFSA") to carry out the activities of a collective investment scheme in the form of a professional investor fund targeting qualifying investors, with registration number SV576 and registered address at 36, Manoel de Vilhena Street, Gzira GZR1012, Malta. The Fund is approved by the Financial Sector Conduct Authority ("FSCA") in South Africa under Section 65 of the Collective Investment Scheme Control Act 2002 and has been categorised as a Collective Investment Scheme for public sale in South Africa. The investment manager systematically identifies individual mispriced securities whilst ensuring sufficient diversification to guard against inappropriate risk concentration. The fund focuses on developed market listed equities worldwide without any limitation to equities of a particular market sector, region, industry or market capitalization, with a maximum gross exposure limit of 400% (i.e. maximum 4x leverage).

## Investment Strategy

The portfolio is managed as a long/short hedge fund. Its core strategy is to be long undervalued equities and short overvalued equities whilst ensuring that there is sufficient diversification to guard against inappropriate risk concentration. The equities are selected by following a "quantamental" investment approach, which combines traditional fundamental analysis with quantitative investment techniques.

## Market Commentary

The respective April net returns for the three Non-Institutional share classes of the fund were +8.1% in US Dollars (USD), +6.4% in Euros (EUR), and +5.3% in British Pounds (GBP). The FTSE Developed World Index, on a total return basis net of dividend tax, returned +10.1% in USD, +8.4% in EUR, and +7.2% in GBP for the month.

In terms of gross sub-strategy attribution for the month, Longs contributed +10.6% and Shorts detracted -4.3%. Special Situations contributed +0.8%, while Futures & Options made no contribution to April's performance. Currency translation added to the return reported in USD but detracted from the returns reported in EUR and in GBP.

Longs listed in Canada, the USA, Great Britain, the Eurozone, Switzerland, Denmark, Norway, Sweden, Hong Kong, and Japan contributed positively for the month. Longs listed in Singapore and Australia detracted from April's performance. Our top Longs for the month were two UK-listed banks, a US health insurer, and a US digital payments company. Our worst-performing Longs were a European beverage company, a US healthcare provider, and a Japanese residential property developer.

Shorts listed in Denmark contributed positively for the month. Shorts listed in the USA, Great Britain, the Eurozone, Switzerland, Sweden, and Norway detracted from April's return. Our top Shorts for the month were a European medical device manufacturer, a Swiss life sciences group, and a US specialty ingredients company. Our worst-performing Shorts were a US autonomous vehicle company, a thematic exchange-traded fund, and a US semiconductor manufacturer.

Special Situations contributed positively to the past month's performance. The fund held no Futures & Options positions during the month. Currency translation contributed to the USD share class return, as most other currencies strengthened against the USD, but detracted from the EUR and GBP share class returns.

We continued to make incremental adjustments to the portfolio by adding to existing long and short positions, while also introducing a new long position. The portfolio remains well diversified, with a continued focus on valuation discipline and prudent risk management.

## Fund Risk

<b>Leverage Risk:</b>	The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.
<b>Derivative Risk:</b>	Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.

<b>Correlation:</b>	A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.
<b>Value at Risk (VaR):</b>	Value at risk is the minimum loss percentage that can be expected over a specified time period at a predetermined confidence level.
