INVESTMENT POLICY

The portfolio will apart from assets in liquid form, invest solely in the HAN -GINS Tech Megatrend Equal Weight ETF, a sub-fund of the HANetf ICAV, domiciled in Ireland. The underlying portfolio's aims to achieve its objective by tracking the Solactive Innovative Technologies Index. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act. Minimum 80% global exposure. The portfolio's equity exposure will be a minimum of 80%.

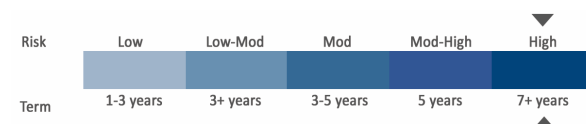

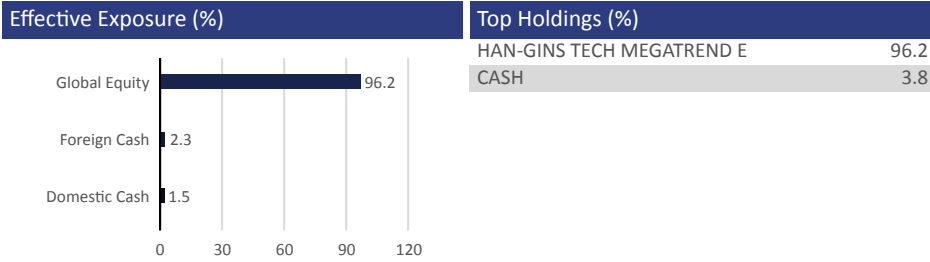
High Risk
