

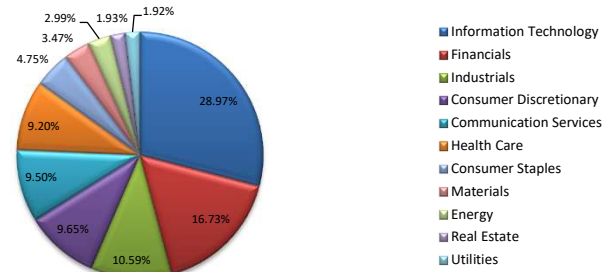

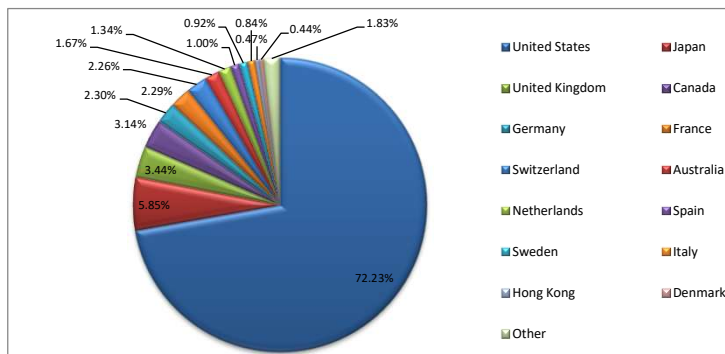
Product Description

Sector Allocation

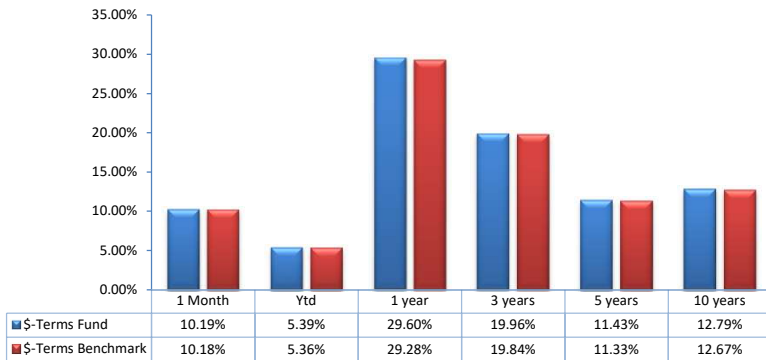


Country Allocation

Forward pricing is used and funds are valued on a daily basis by no later than 17h00. Figures quoted are from GinsGlobal Index Funds using NAV-NAV prices, with income and dividend distributions reinvested in the Portfolio. Highlights: The Total Expense Ratio (TER) for this class of portfolio is indicated on the website www.ginsglobal.com. Each TER is the annualized percent of the average Net Asset Value of the portfolio incurred as charges, levies and fees. Presently there is a maximum of 10bps custody, admin and audit fee on this fund. This fee is not taken into account in the gross returns of these funds.
